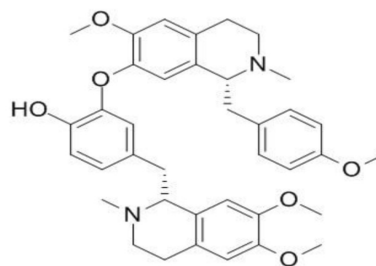

### BIOLOGICAL ACTIVITY OR INHIBITORS

Neferine shows significant improvement in cognitive impairment in scopolamine-induced amnesia animal models and moderate inhibitory activities in cholinesterases (ChEs) and beta-site APP cleaving enzyme 1 (BACE1) assays; it also exhibits notable scavenging activities against DPPH, ABTS, NO, and O(2)(-) radicals, as well as ONOO(-), it demonstrates remarkable inhibitory activity against lipid peroxidation and protein nitration in cell-free antioxidant assays and moderate inhibitory activity of NO generation with exceptional suppression of NF-kappaB activation in cell-based assays; suggests that the anti-amnesic effect of neferine may be mediated via antioxidant and anti-inflammatory

Neferine induces autophagy through the inhibition of PI3K/Akt/mTOR pathway and ROS

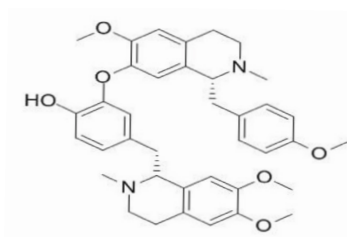
