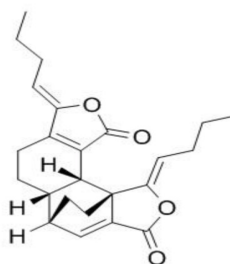

Levistolide A (LA) has reversing effect on P-glycoprotein (P-gp)-mediated multidrug resistance (MDR) in human breast carcinoma Bcap37/MDR1 cells, it dramatically enhances the verapamil (VER) ability to reverse drug resistance, LA has the potential to be developed as a novel P-gp modulator, and the combination of LA and VER may represent a more sufficient but less toxic anti-MDR regimen. 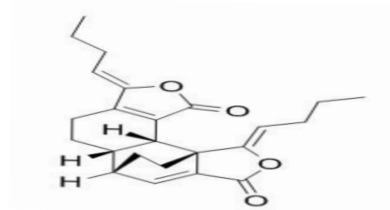
