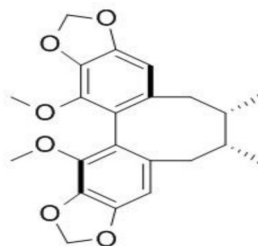

BIOLOGICAL ACTIVITY OR INHIBITORS

Schizandrin C isolated from Schisandra chinensis could be used as a natural anti-neuroinflammatory agent, inducing phase II detoxifying/antioxidant enzymes via cAMP/PKA/CREB and Nrf-2 signaling. [1]

A Schizandrin C derivative DDB-mixed preparation (DWP-04) has preventive effect against hepatotoxicity induced by carbon tetrachloride; schizandrin C and its analogs are antihepatitic drugs. [2,3]

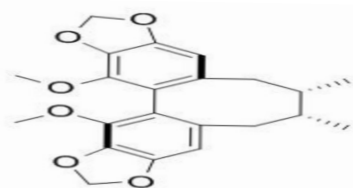
