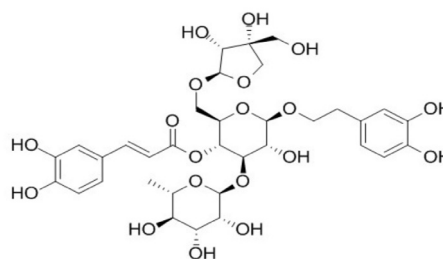

Forsythoside B can exert potent neuroprotective effects with a favorable therapeutic time-window, reduce of cerebral ischemia and reperfusion injury degree, attenuating blood-brain barrier (BBB) breakdown, and its protective effects may be due to inhibition of

Forsythoside B has antisepsis effect, the effect is mediated by decreasing local and systemic levels of a wide spectrum of inflammatory mediators; its antisepsis mechanism may be that Forsythoside B binds to LPS and reduces the biological activity of serum LPS, and inhibits NF- κ B activation, suggests that forsythoside B itself has promise as a therapy for the treatment of sepsis in humans. 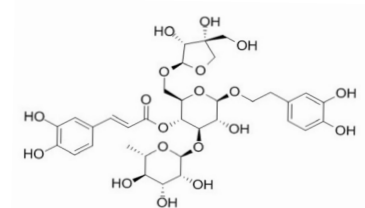
