Secoisolariciresinol diglucoside (SDG) is a plant lignan isolated from flaxseed, SDG is an antioxidant, SDG can reduce hypercholesterolemic atherosclerosis and that this effect is associated with a decrease in serum cholesterol, LDL-C, and lipid peroxidation product development of diabetes.[1]

Secoisolariciresinol diglucoside can induce neovascularization-mediated cardioprotection against ischemia-reperfusion injury in hypercholesterolemic myocardium, SDG treatment[3]

Secoisolariciresinol diglucoside is a phytoestrogen, estrogens and phytoestrogen from

soy have been reported to have mild hypotensive effects, and SDG is a long-acting

hypotensive agent, and that the hypotensive effect is mediated through the guanylate metastasis of melanoma cells in mice. [4]
