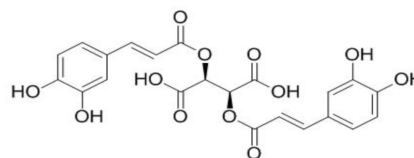

BIOLOGICAL ACTIVITY OR INHIBITORS

Beta-mangostin shows cytotoxic activity against the human lung cancer cell line (NCI-H187) , it also shows anti-malarial activity against Plasmodium falciparum with IC(50) tuberculosis with the minimum inhibitory concentration (MIC) value of 6.25 microg/ml.[1]

Alpha-and beta-mangostins exhibit strong inhibitory effect against Mycobacterium values of 7.2 microg/ml.[2]

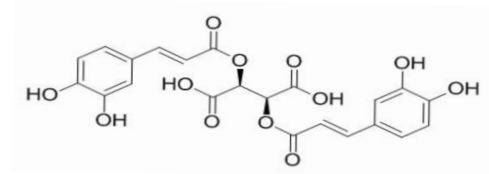
