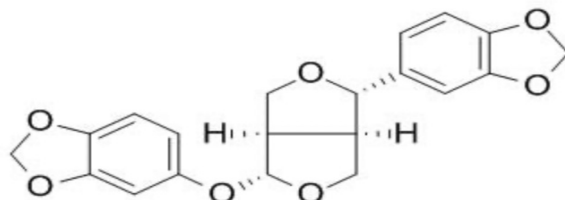

Sesaminol possesses antioxidative activity, can inhibit lipid peroxidation in rat liver and kidney [1].  
Sesamol has protective effect on hypoxic neuronal and PC12 cells, it may be related to suppression of ROS generation and MAPK activation.[2]  
Sesamol can inhibit proliferation by inducing apoptosis in human lymphoid leukemia Molt 4B cells. [3]  
Sesamol has protective effects on murine BV-2 microglia cell line under hypoxia, the mechanism involves inhibition of MAPK pathways and apoptosis through scavenging of [4]  
Sesamol exerts effective neuroprotection against cerebral ischemia. [5]

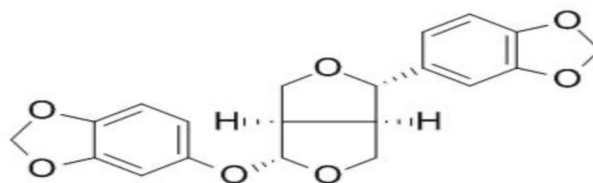
