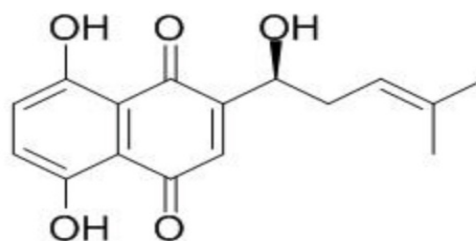

### BIOLOGICAL ACTIVITY OR INHIBITORS

Shikonin is a natural red naphthoquinone pigment synthesized in the roots of plants belonging to the Boraginaceae family; at present, a purified shikonin preparation is widely used in Japan for the production of medicinals, cosmetics, and some food products; in Russia, shikonin enters into the antiinflammatory ointment and cream compositions used for the treatment of burns; shikonin also possesses a broad spectrum of antimicrobial [1]

Shikonin can inhibit the growth and induce the apoptosis of HepG2 cells significantly, [2] treatment of lung adenocarcinoma.

Shikonin can suppress inflammatory reactions, the inhibition of Syk-dependent phosphorylation events might underlie the blocked histamine release from human

[4] activity.

which may be related with the PI3/Akt signal pathway.

Shikonin may inhibit the growth of lung adenocarcinoma cell by changing cell cycle and promoting cell apoptosis through the regulation of CCND1, caspase3, and caspase7, suggests that shikonin has the potential to be used as an anti-cancer agent in the

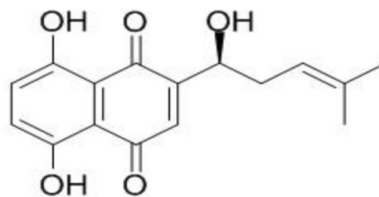
