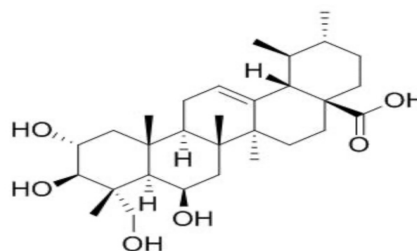

BIOLOGICAL ACTIVITY OR INHIBITORS

Madecassic acid (MA) is an abundant triterpenoid in *Centella asiatica* (L.) Urban. (Apiaceae) that has been used as a wound-healing, anti-inflammatory and anti-cancer agent; it can protect against hypoxia-induced oxidative stress in retinal microvascular endothelial cells via ROS-mediated endoplasmic reticulum stress; indicates that the regulation of oxidative stress and ER stress by MA would be a promising therapy to

[1] reverse the process and development of hypoxia-induced hRMECs dysfunction. Madecassic acid has anti-inflammatory properties in RAW 264.7 macrophage cells, the properties are caused by iNOS, COX-2, TNF-alpha, IL-1beta, and IL-6 inhibition via the [2]

Madecassic acid inhibits in vivo CT26 cell-induced tumor growth by facilitating cell apoptosis and increasing immune defense mechanisms. [3]

Madecassic acid can improve glycemic control and hemostatic imbalance, lower lipid accumulation, and attenuate oxidative and inflammatory stress in diabetic mice; thus, madecassic acid could be considered as an anti-diabetic agent. [4]

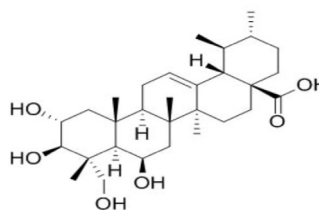
