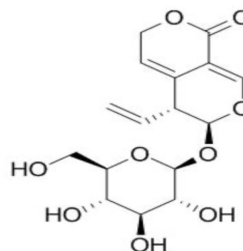

## BIOLOGICAL ACTIVITY OR INHIBITORS

---

gentiopicroside, a secoiridoid glycoside isolated from the methanol extract of the aerial parts of *Centaurium erythraea*, has antibacterial and free radical scavenging activities, it also has general toxicity in brine shrimp lethality. [1]

Gentiopicroside has smooth muscle relaxing activity. [2]

Gentiopicroside exhibits analgesic activities and attenuates morphine rewarding effect through downregulation of GluN2B receptors in nucleus accumbens. [3]

Gentiopicroside has been developed into a novel traditional Chinese drug named gentiopicroside injection, and it was approved for the treatment of acute jaundice and chronic active hepatitis by SFDA. [4]

Gentiopicroside exhibits obvious anti-inflammatory effects, it can decrease the permeability of celiac blood capillary, and reduce the paw swelling induced by carrageenan and zymosan A; it can prevent interleukin-1 beta induced inflammation response in rat articular chondrocyte; gentiopicroside treatment can exert anti-inflammatory effects on experimental acute colitis through attenuating the expression levels of TNF- $\alpha$ , IL-1 $\beta$ , IL-6, iNOS and COX-2, and it may present the therapeutic potential in the treatment of colitis. 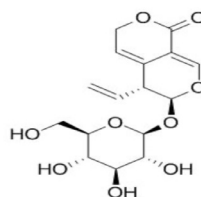
