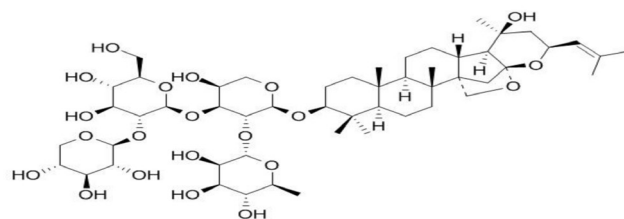

BIOLOGICAL ACTIVITY OR INHIBITORS

Jujuboside B is one of the saponins isolated from the seeds of *Zizyphus jujuba* var, has antitumor activity and the underlying mechanism via induction of apoptosis and autophagy [1]

Jujuboside B has potent inhibitory effects on collagen-, thrombin-, AA-, and ADP-induced aggregation, also exhibits superior protection on thromboembolic model, it has a significant inhibitory effect on collagen-induced thromboxane A2 production in rat platelets; suggest that it be considered as components of preventive and therapeutic herbal drugs targeting cardiovascular diseases associated with platelet hyperaggregation. Jujuboside B reduces vascular tension endothelium-dependently by increasing

Ca²⁺Influx and activating endothelial nitric oxide synthase, it is a natural compound with

new pharmacological effects on improving endothelial dysfunction and treating vascular diseases [3]

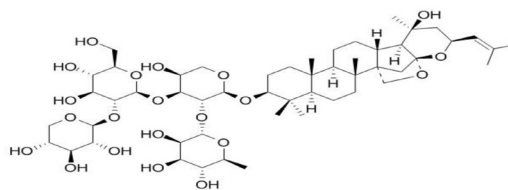
