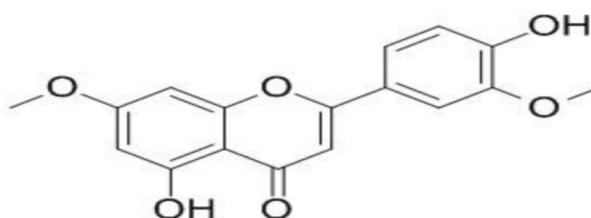

BIOLOGICAL ACTIVITY OR INHIBITORS

Velutin, a unique flavone isolated from the pulp of açai fruit (*Euterpe oleracea* Mart.), has strong anti-inflammatory, can effectively inhibit the expression of proinflammatory cytokines TNF- α and IL-6 in low micromole levels by inhibiting NF- κ B activation and p38 and JNK phosphorylation. [1]
Velutin exhibits the strongest effects in reducing both TNF- α and IL-6 dose-dependently in the two type cells, it also strongly inhibits NF- κ B activation, suggests that it effectively inhibits proinflammatory cytokine production in low micromole levels by inhibiting NF- κ B activation through blocking the degradation of I κ B. [2]
Velutin controls HIF-1 α activity during PgLPS-activated osteoclastogenesis probably through modulation of the NF- κ B pathway, perhaps it could be used therapeutically to [3]
Velutin and betulinic acid can induce apoptosis in tumor cells.[4]

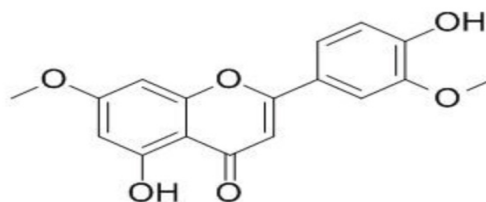
