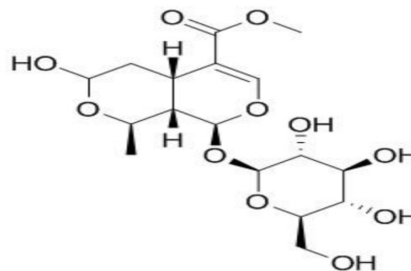

BIOLOGICAL ACTIVITY OR INHIBITORS

Morrnonside, an iridorid glycoside isolated from *Cornus officinalis* Sieb. Et Zucc., has shown potent antioxidant properties, it can protect human neuroblastoma SH-SY5Y cells against hydrogen peroxide-induced cytotoxicity, suggests that morrnonside has protective effects against oxidative stress-induced neurotoxic processes. [1] Morrnonside exhibits protective effects against diabetic renal damage by inhibiting hyperglycemia and oxidative stress, indicates that morrnonside is one component partly responsible for the protective effects of Corni Fructus and Hachimi-jio-gan against diabetic renal damage. [2] Administration of morrnonside significantly increases hepatic peroxisome proliferator activated receptor alpha expression, morrnonside would act as a regulator of hepatic inflammatory reactions and lipid metabolism in db/db mice; it may inhibit abnormal lipid metabolism and inflammation due to reactive oxygen species in the kidneys in type 2 [3,4] Morrnonside and loganin have protective effects on rat mesangial cell proliferation exposed to advanced glycation end products by preventing oxidative stress. [5] Morrnonside can improve microvascular functional integrity of the neurovascular unit after cerebral ischemia, it may offer a novel therapeutic approach for promoting microvascular integrity recovery and provide a thoroughly new direction for stroke therapy. [6] Morrnonside can promote bone marrow mesenchymal stem cell proliferation in rats. [7] Morrnonside can decrease the level of cyclooxygenase(Cox) and it may be the mechanism of morrnonside on inhibiting the platelet aggregation induced by ADP in rabbits. [8]

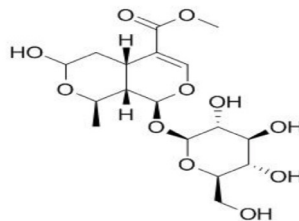
