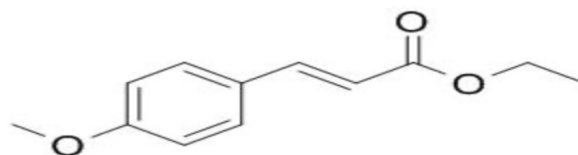

### BIOLOGICAL ACTIVITY OR INHIBITORS

Ethyl p-methoxycinnamate (Ethyl 4-methoxycinnamate) has antifungal activity, it can inhibit the growth of *Trichophyton rubrum*, *Aspergillus niger*, *Saccharomyces cerevisiae* and *Epidermophyton floccosum* at a concentration less than 10 µg/ml. [1]

Ethyl p-methoxycinnamate has chemopreventive activity against fibrosarcoma through inhibition of COX-2. [2]

Ethyl-p-methoxycinnamate has anti-inflammatory, it can dose-dependently inhibit carrageenan-induced edema with an MIC of 100 mg/kg, and non-selectively inhibit the activities of cyclooxygenases 1 and 2, with IC<sub>50</sub> values of 1.12 µM and 0.83 µM respectively. [3]

Ethyl p-methoxycinnamate can significantly decrease melanin synthesis in B16F10 murine melanoma cells stimulated with α-melanocyte stimulating hormone (α-MSH), the pigment-inhibitory effect of ethyl p-methoxycinnamate results from downregulation of tyrosinase, it could be developed as a skin whitening agent to treat hyperpigmentary disorders [4]

trans-Ethyl p-methoxycinnamate can specifically inhibit the migration and tube formation of human umbilical vein endothelial cells, it can block bFGF-induced vessel formation [5]

Ethyl p-methoxycinnamate has cytotoxic activity against human breast cancer (MCF-7) [6]

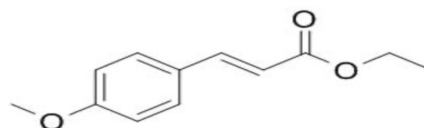
