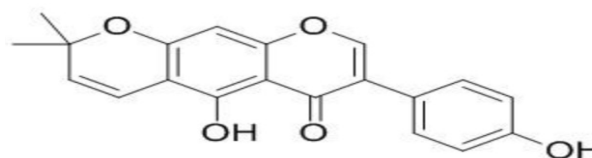

### BIOLOGICAL ACTIVITY OR INHIBITORS

Alpinumisoflavone and abyssinone V-4'-methyl ether are endowed with estrogenic properties accounting, at least in part, for E. lysistemon effects. [1]

Alpinumisoflavone can induce cell death of human lung tumor cells by apoptosis, it also represses lipopolysaccharide (LPS)-induced nitric oxide (NO) production in RAW264.7 cells by inhibiting NF-κB-dependent transcription, therefore, the cell death induced by alpinumisoflavone may be via repressing both the ERK/MAPK and NF-κB pathways. Alpinumisoflavone and abyssinone V 4'-methylether can induce analogous effects on lipid profile and decrease atherogenic risks, they downregulate the mRNA expression of Esr1, a gene associated with cholesterologenesis and cholesterol gallstone formation and may also promote the conversion of cholesterol into bile acids as they upregulate Cyp7a1 mRNA expression; thus, their atheroprotective effects may result from their ability to upregulate mechanisms promoting HDL-cholesterol and bile acid formation. Alpinumisoflavone, abyssinone-V 4'-O-methyl ether, 6,8-diprenylgenistein, and burttinone are active against both Gram-negative and Gram-positive bacteria, the minimum inhibitory concentration values obtained (MIC) ranged from 3.9 µg/mL to 125 µg/mL. [4]

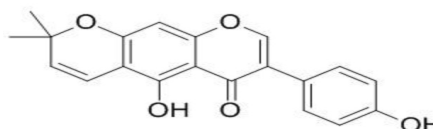
