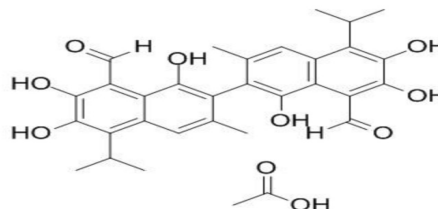

Gossypol acetate is a potent inhibitor of Bcl-2 and Bcl-xl, it has significant antiproliferative and antiapoptotic effects on multiple myeloma cells in vitro and in vivo, it may represent a promising new anticancer agent for human multiple myeloma with Bcl-2 overexpression. Gossypol acetate has [2] apoptosis-inducing activity in primary cultured leukemia cells from patients diagnosed as acute lymphoblastic leukemia (ALL) and chronic lymphocytic leukemia (CLL) in vitro. 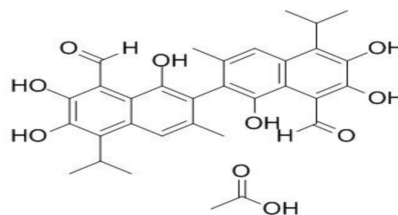
