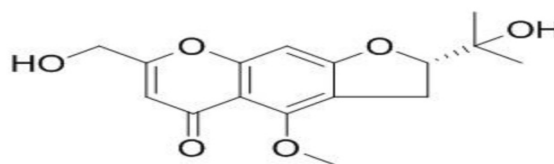

BIOLOGICAL ACTIVITY OR INHIBITORS

Cimifugin, isolated from *Peucedanum schottii*, displays low to moderate inhibition towards AChE and BChE (3.12 and 21.63%, respectively) at 200 ug mL⁻¹. [1]

Cimifugin evidently inhibits FITC-induced type 2 allergic contact dermatitis, and its mechanism might be related to regulating the balance of Th1 /Th2 by inhibiting type 2 cytokines [2]

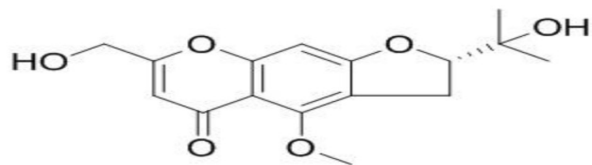
