BIOLOGICAL ACTIVITY OR INHIBITORS

Isovitexin, a food phytochemical contained in dietary rice products, it can suppress

lipopolysaccharide-mediated inducible nitric oxide synthase through inhibition of NF-kappa B in mouse macrophages. [1]

Isovitexin has antioxidant properties, it inhibits xanthine oxidase with an IC50 value [2]

Isovitexin and vitexin are C-glycosyl bioflavonoids, exhibit in vivo a-glucosidase inhibition, show a strong antihyperglycemic action . [3,4]

Isovitexin exerts anti-inflammatory and anti-oxidant activities on lipopolysaccharide-

induced acute lung injury by inhibiting MAPK and NF-κB and activating HO-1/Nrf2 [5]

Isovitexin has neuroprotective effect against glutamate-induced cell damage in mice hippocampal slices. [6]
