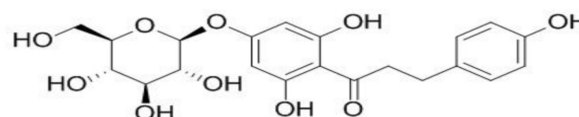

BIOLOGICAL ACTIVITY OR INHIBITORS

Trilobatin has a moderate antioxidant potential, it shows a strong inhibitory activity against α -glucosidase and a moderate inhibitory activity against α -amylase for management of postprandial hyperglycemia with less side effect. [1]

Trilobatin has anti-inflammatory effect, it potentially inhibits the lipopolysaccharide(LPS)-induced inflammatory response by suppressing the NF- κ B signaling pathway. [2]

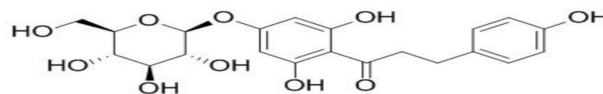
