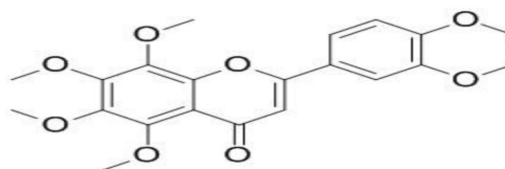

### BIOLOGICAL ACTIVITY OR INHIBITORS

Nobiletin, a citrus polymethoxy flavonoid, has anti-inflammatory actions on human synovial fibroblasts and mouse macrophages. [1]

Nobiletin has an inhibitory effect on phorbol ester-induced skin inflammation, oxidative stress, and tumor promotion in mice; it is a functionally novel and possible chemopreventive agent in inflammation-associated tumorigenesis. [2]

Nobiletin decreases the A $\beta$  burden and plaques in the hippocampus of APP-SL 7-5 Tg mice; it improves memory impairment and A $\beta$  pathology in a transgenic mouse model [3]

Nobiletin has anti-tumor effects and antiproliferative effects via induction of apoptosis and cell cycle deregulation. [4]

Nobiletin exhibits various pharmacological effects including anti-inflammatory, antitumor, and neuroprotective properties; it improves hyperglycemia and insulin resistance in obese [5]

Nobiletin improves brain ischemia-induced learning and memory deficits through stimulation of CaMKII and CREB phosphorylation. [6]

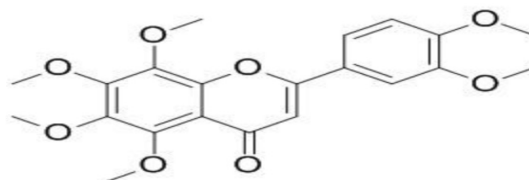
