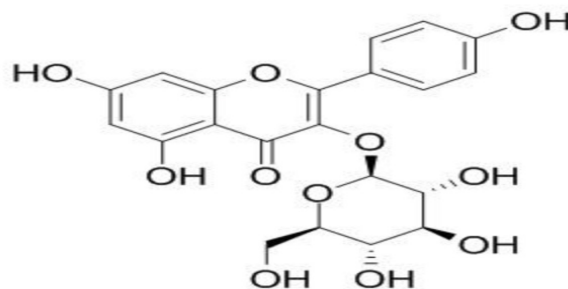

### BIOLOGICAL ACTIVITY OR INHIBITORS

---

Astragalín (kaempferol-3-O-glucoside), a newly found flavonoid from leaves of persimmon or *Rosa agrestis*, is known to have anti-atopic dermatitis and antioxidant activity; it also has anti-inflammatory activity, inhibits expression of proinflammatory mediators through the inhibition of NF- $\kappa$ B in macrophages. [1]

Astragalín has antiallergic effects on atopic dermatitis-model mice. [2]

Astragalín has antioxidant effect against free radical-induced oxidative hemolysis of human red blood cells.[3]

Astragalín can be effective in allaying ROS-promoted bronchial fibrosis through inhibiting autophagosome formation in airways. [4]

Astragalín decreases the overexpression of vascular endothelial growth factor (VEGF) in

Müller cells and alleviates the effects caused by high glucose, thus, it has promising

application in preventing and treating diabetic retinopathy (DR) caused by diabetes [5]

Astragalín inhibits IL-1 $\beta$ -induced inflammatory mediators production in human osteoarthritis chondrocyte by inhibiting NF- $\kappa$ B and MAPK activation. [6]

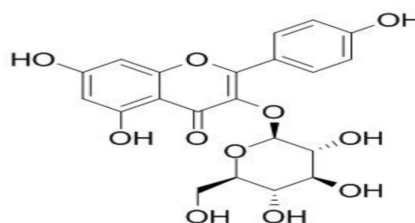
