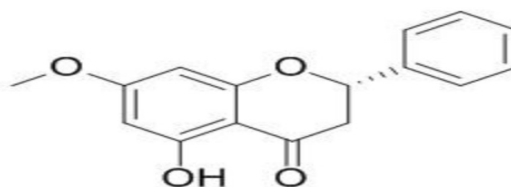

BIOLOGICAL ACTIVITY OR INHIBITORS

Linarin is a flavone glycoside in the plants *Flos chrysanthemi indicii*, *Buddleja officinalis*, *Cirsium setosum*, *Mentha arvensis* and *Buddleja davidii*, possesses analgesic, antipyretic, anti-inflammatory and neuroprotective activities. [1]

Linarin is known to have anti-acetylcholinesterase effects, prevents A β (25-35)-induced neurotoxicity through the activation of PI3K/Akt, which subsequently inhibits GSK-3 β and up-regulates Bcl-2, may be a potent therapeutic compound against Alzheimer's disease acting through both acetylcholinesterase inhibition and neuroprotection. Linarin has dose-dependent analgesic and anti-inflammatory activities. [3]

Linarin can protect osteoblasts against hydrogen peroxide-induced osteoblastic dysfunction and may exert anti-resorptive actions, at least in part, via the reduction of RANKL and oxidative damage. [4]

Linarin induces the osteogenic differentiation and mineralization of MC3T3-E1 osteoblastic cells by activating the BMP-2/RUNX2 pathway through PKA signaling *in vitro* and protected against OVX-induced bone loss *in vivo*, suggests that linarin is a useful natural alternative for the management of postmenopausal osteoporosis. 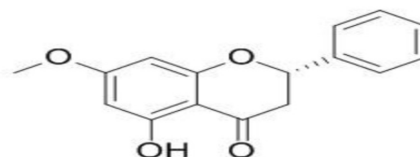
