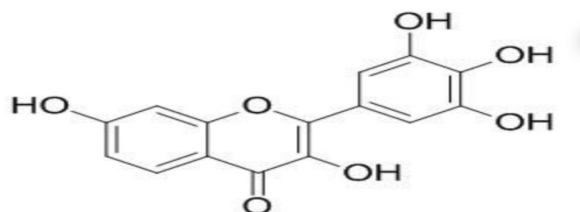

### BIOLOGICAL ACTIVITY OR INHIBITORS

Plant-derived flavanol (-)epicatechin enhances angiogenesis and retention of spatial memory in mice. [1]  
Oral administration of chemically pure (-)-epicatechin to humans closely emulates acute vascular effects of flavanol-rich cocoa, suggests that (-)-epicatechin mediates beneficial effects of flavanol-rich cocoa on vascular function in humans. [2]

Epicatechin exerts antioxidative effects, it has protective effect on lipid peroxidation[3]

Epicatechin has antinociceptive effect, it may be effective to treat nociceptive hypersensitivity in diabetic patients. [4]

(-)-Epicatechin has the potential to increase CREB-regulated gene expression and increase GluR2 levels and thus modulate neurotransmission, plasticity and synaptogenesis [5]

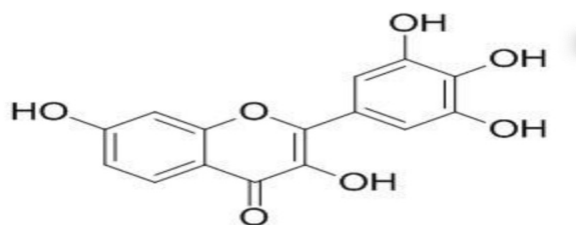
