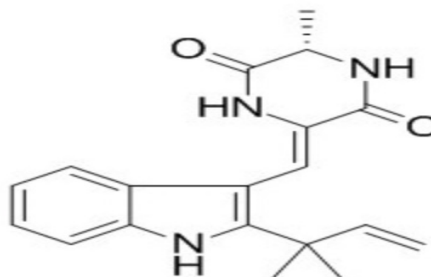

BIOLOGICAL ACTIVITY OR INHIBITORS

Neoechinulin A, an indole alkaloid isolated from marine-derived *Microsporium* sp., can attenuate microglial activation by oligomeric amyloid- β 1–42 (A β 42), it significantly inhibits the generation of reactive oxygen and nitrogen species in A β 42-activated BV-2 microglia cells, it also suppresses the production of neurotoxic inflammatory mediator tumour necrosis factor- α (TNF- α), interleukin-1 β (IL-1 β), interleukin-6 (IL-6), and prostaglandin E 2 (PGE 2) in activated BV-2 cells; regulation of these signalling pathways have most probably contributed to the anti-inflammatory activity of neoechinulin A, suggests that with further studies neoechinulin A have a potential to be developed as a modulator of neuroinflammatory process in Alzheimer's disease. Neoechinulin A has anti-inflammatory effects in LPS-stimulated RAW264.7 macrophages through the inhibition of the NF- κ B and p38 MAPK pathways, suggests that it may be a potential therapeutic agent for the treatment of various inflammatory diseases. [2]

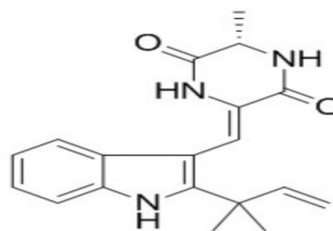
