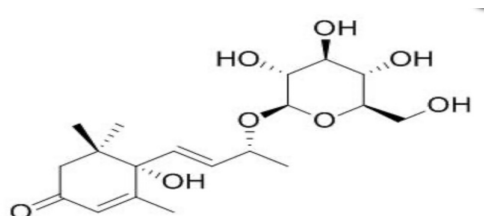

BIOLOGICAL ACTIVITY OR INHIBITORS

Roseoside (vomifoliol glucosides) exhibits inhibitory activity on leukotriene release from induced by antigen-antibody reaction. [1]

(6S,9R)-Roseoside can inhibit the histamine release from rat peritoneal exudate cells mouse bone marrow-derived cultured mast cells (BMCMC). [2]

Roseoside significantly delays carcinogenesis induced by peroxynitrite (initiator) and TPA (promoter), and its potency was comparable to that of a green tea polyphenol [3]

Roseoside possesses strong antioxidant properties, inhibiting lipid oxidation by 86.4, at 50 microg/mL. [4]

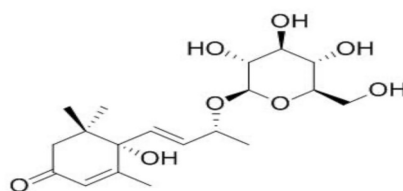
