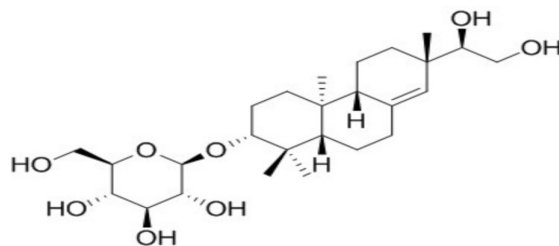

Darutoside, a compound of the Chinese medicinal herb Herba Siegesbeckiae (HS), HS has long been used as a remedy for traditional Chinese medicine symptoms that resemble inflammatory joint disorders, because it can eliminate the wind-dampness and soothe painful joints; the processing with rice wine can significantly reduce the cytotoxicities and enhance the anti-inflammatory effects of HS as demonstrated in cell models [1] Darutoside has been investigated for many years as an appropriate treatment for wounds [2]

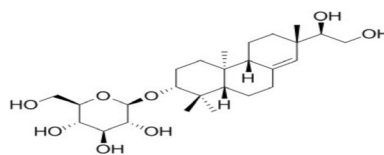
