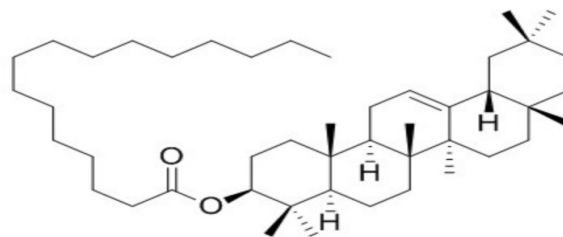

### BIOLOGICAL ACTIVITY OR INHIBITORS

beta-Amyrin palmitate has antidepressant activity, it may release norepinephrine from newly synthesized pools, and thus, it may activate noradrenergic activity. [1]

$\beta$ -Amyrin palmitate and  $\beta$ -amyrin acetate have antidyslipidemic activity, they show significant HMG-CoA-reductase inhibition. [2]

$\beta$ -Amyrin palmitate has remarkable anti-hyperglycemic activity in orally glucose loaded rats, it exhibits excellent anti-diabetes mellitus activity in both alloxan-diabetic and streptozotocin-diabetic rats at a very low concentration (50ug/kg body weight); one of the mechanisms of action of  $\beta$ -amyrin palmitate appears to be blocking the entry of glucose [3]

$\beta$ -Amyrin palmitate possesses high anti-inflammatory activity at the low concentration 0.0102uM [4]

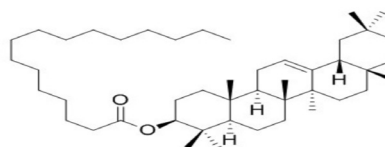
