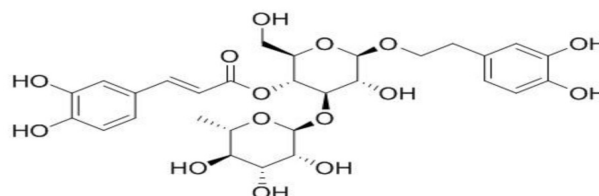

### BIOLOGICAL ACTIVITY OR INHIBITORS

Acteoside is the most abundant and major active component of *Ligustrum purpurascens* (kudingcha tea), it is a lipase inhibitor, has anti-obesity properties. [1]

Acteoside has protective effects against the carbon tetrachloride-induced hepatotoxicity, the mechanisms possibly related to its ability to block the P450-mediated carbon tetrachloride bioactivation and free radical scavenging effects; it can inhibit apoptosis [2]

Acteoside inhibits human promyelocytic HL-60 leukemia cell proliferation via inducing cellcycle arrest at G0/G1 phase and differentiation into monocyte. [4]

Acteoside significantly inhibits arachidonic acid release and prostaglandin E2 production induced by 0.5 microM melittin, it is possible that acteoside may be developed as an anti-inflammatory agent. [5]

Acteoside can protect SH-SY5Y cells against  $\beta$ -amyloid-induced cell injury by the attenuating ROS production and the modulating apoptotic signal pathway through Bcl-2 family, cytochrome c , and caspase-3. [6]

Acteoside and martynoside exhibit anticancer, cytotoxic and antimetastatic activities; its antiproliferative effect on endometrial cells suggests that martynoside may be an important natural SERM; acteoside is an antiestrogen in breast cancer cells [7]

Acteoside and its analogs have antioxidant and antihypertensive activities [ 8,9 ]

Acteoside has analgesic activity, it as the Analgesic Principle of Cedron (*Lippia hriphylla*), a Peruvian Medicinal Plant. [10]

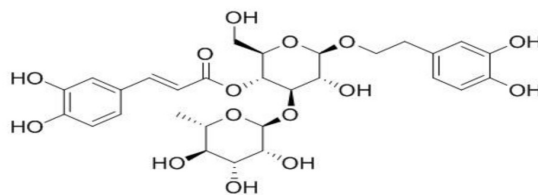
