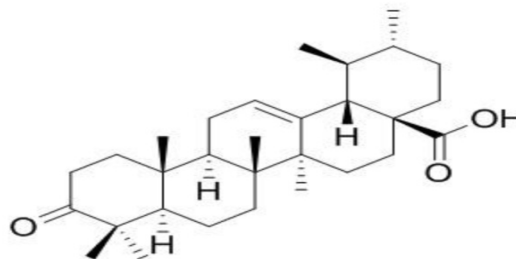

Ursonic acid, ursolic acid, and 3-oxofriedelan-28-oic acid show significant cytotoxic activities against three human cancer cell lines(HONE-1 nasopharyngeal carcinoma, KB oral epidermoid carcinoma, and HT29 colorectal carcinoma cells), with IC50 values [1]

Ursonic acid shows antiviral activity against Herpes simplex virus types I and II in vitro.[2]

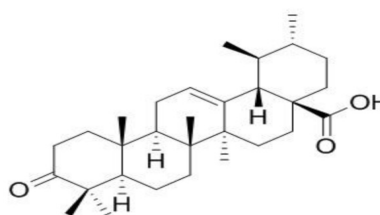
