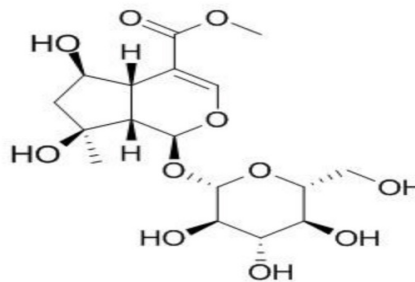

### BIOLOGICAL ACTIVITY OR INHIBITORS

Shanzhiside methylester, the principle effective iridoid glycoside from the analgesic herb *Lamiophlomis rotata*, reduces neuropathic pain by activating spinal GLP-1 receptors and subsequently stimulating microglial  $\beta$ -endorphin expression via the p38 MAPK signaling; stimulation of the endogenous  $\beta$ -endorphin expression may be a novel and effective strategy for the discovery and development of analgesics for the long-term treatment of chronic pain. 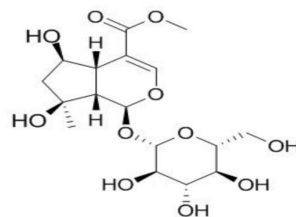
