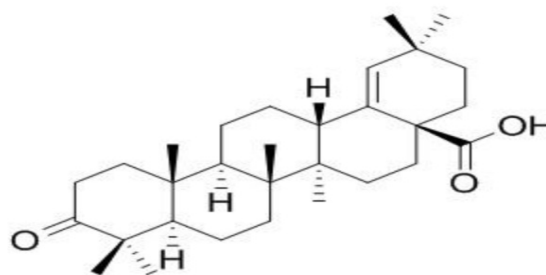

BIOLOGICAL ACTIVITY OR INHIBITORS

Moronic acid, a simple triterpenoid keto acid isolated from *Ozoroa mucronata*, shows antimicrobial activity against Gram-positive bacteria. [1]

Moronic acid shows significant anti-HIV activity (EC₅₀ 186) and was modified to develop [2]

Moronic acid shows oral therapeutic efficacy in HSV-infected mice and possesses novel anti-HSV activity. [3]

Moronic and moronic acids have shown sustained antidiabetic and antihyperglycemic

action possibly mediated by an insulin sensitization with consequent changes of glucose,

cholesterol and triglycerides, in part mediated by inhibition of 11 β -HSD 1 as indicated by in vitro. [4]

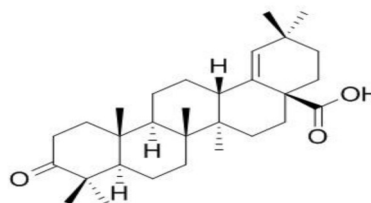
