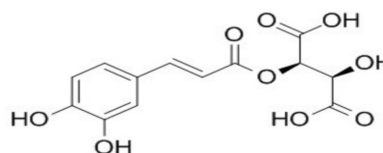

Caftaric and chlorogenic acids are the major dietary polyphenols present in various foods, they before methamphetamine injections can prevent liver toxicity and oxidative stress where chlorogenic acid is more effective. [1]

Caftaric acid is a component responsible for antimutagenicity in the juice of *V. coignetiae* towards the carcinogenic heterocyclic amine 3-amino-1-methyl-5H-pyrido[4,3-b]indole (Trp-P-2), it as an inhibitor of the protein-protein interactions mediated by the Src-family kinases [2]

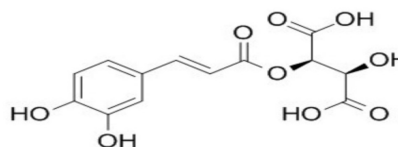
