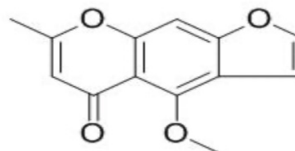

BIOLOGICAL ACTIVITY OR INHIBITORS

Visnagin and khellin can prevent renal epithelial cell damage caused by oxalate (Ox) and calcium oxalate monohydrate (COM) and can therefore play a potential role in the prevention of stone formation associated with hyperoxaluria. [1]
Visnagin can relax aortae previously contracted by noradrenaline, and weakly inhibit the hydrolytic activity of the cyclic nucleotide phosphodiesterase (PDE) isozymes (PDE5, [2]
Visnagin has acute hypotensive effect , the main mechanism is the vasorelaxant response induced by this drug in resistance arteries. [3]
Visnagin has anti-inflammatory effect in lipopolysaccharide-stimulated BV-2 microglial cells, the main mechanism may result from the inhibition of transcription factors, such as [4]
Visnagin protects against doxorubicin-induced cardiomyopathy through modulation of mitochondrial malate dehydrogenase. [5]
Visnagin has neuroprotective effects on kainic acid-induced neuronal cell death in the mice hippocampus, the neuroprotective effects are associated with its anti-inflammatory effects [6]

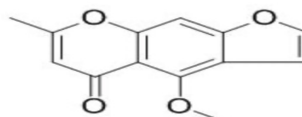
