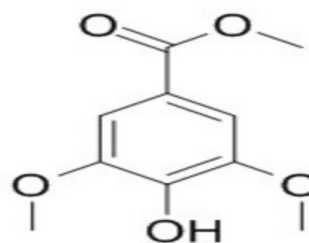

BIOLOGICAL ACTIVITY OR INHIBITORS

Methyl syringate is an aflatoxin production inhibitor; it can inhibit aflatoxin production of *Aspergillus parasiticus* and *Aspergillus flavus* with IC50 values of 0.9 and 0.8 mM, respectively, without significantly inhibiting fungal growth. [1]

Methyl syringate is an activator of the chemosensory ion channel TRPA1. [2]

Methyl syringate is a specific and selective agonist of the human transient receptor potential channel ankyrin 1 (TRPA1) and suppresses food intake and gastric emptying in imprinting control region mice; it inhibits the hypoxic induction of COX-2 expression and cell invasion through TRPA1 activation, suggests that methyl syringate could be effective to suppress hypoxia-induced inflammation.[3]

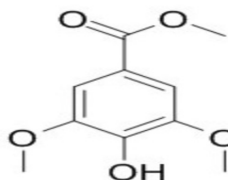
