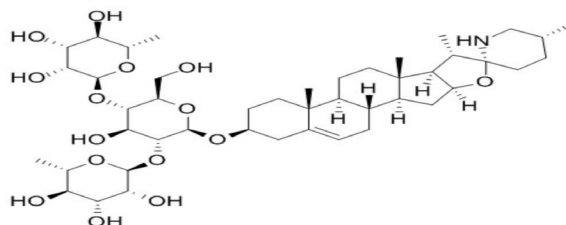

BIOLOGICAL ACTIVITY OR INHIBITORS

Solamargine (SM), an herbal and molluscicidal medicine derived from *Solanum incanum*, displays a superior cytotoxicity in four human lung cancer cell lines, the half-inhibitory concentrations (IC₅₀), of the cell viability assay for H441, H520, H661 and H69 cells were 3, 6.7, 7.2 and 5.8 μ M, respectively; it can modulate the expressions of TNFRs and Bcl-2, and might be a potential anticancer agent for TNFs and Bcl-2 related resistance of human [1] Interactions between the glycoalkaloids solasonine and solamargine have inhibition of fungal growth. [2] Solamargine exerts potential anticancer activity on SMMC-7721 cells in vitro through the activation of caspase-3 and the regulation of the cell cycle progression to induce apoptosis and inhibit hepatoma cells proliferation. [3] Solamargine induces Fas and tumor necrosis factor receptors (TNFRs)-induced NSCLC cell apoptosis and reduces HER2 expression, provides the synergistic therapeutic interaction between SM and epirubicin, suggesting that such combinations may be effectively exploited in future human cancer clinical trials. [4]

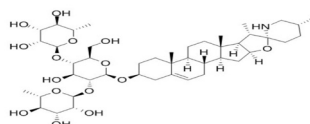
