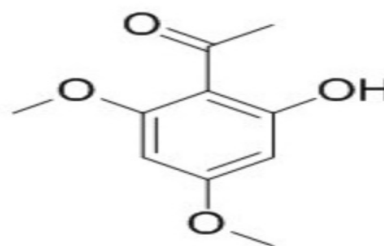

Xanthoxylin induces melanogenesis mainly via cAMP-mediated PKA activation, other signaling pathways may also play a role in xanthoxylin-induced melanogenesis. [1]

Xanthoxyline and its derivatives have fungistatic effect against a panel of yeasts, [2] filamentous fungi and dermatophytes. [3]

Xanthoxylin has inhibitory effect on blood platelet aggregation in rabbits. [4]

Xanthoxyline derivatives has antinociceptive and antioedematogenic activities. [5]

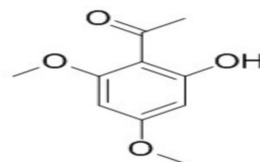
