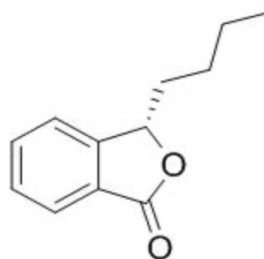

BIOLOGICAL ACTIVITY OR INHIBITORS

DI-3-n-Butylphthalide(NBP), an established natural antioxidant for clinical stroke treatment in China, can reportedly reduce beta-amyloid-induced neuronal toxicity in cultured neuronal cells, and attenuate neurodegenerative changes in aged rats; it can upregulate the vesicular monoamine transporter 2 gene expression in vitro and in vivo; it protects dopaminergic (DA) neurons likely by reducing oxidative stress, offering an alternative [1] 3-n-Butylphthalide may have a protective effect for diabetic brain damage through enhancing VEGF expression to inhibit caspase-3 mediated apoptosis. 3-n-Butylphthalide is a potentially beneficial drug for the treatment of ischemic stroke with multiple actions on different pathophysiological processes, NBP exerts oral anti-platelet and anti-thrombotic efficacy without perturbing systemic hemostasis in rats, and l-NBP is [3]

L-Butylphthalide may protect neurons against A β -induced neurotoxicity via inhibiting tau protein hyperphosphorylation. [4]

3-n-Butylphthalide, especially its s(-)-enantiomer, can potently reduce the release of cytochrome c, decrease the activation of caspase-3, and inhibit DNA fragmentation after transient focal cerebral ischemia; the beneficial effects of NBP on cerebral ischemia-induced apoptosis might have important implications for the study and treatment of ischemic cerebrovascular diseases. 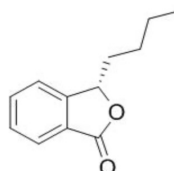
