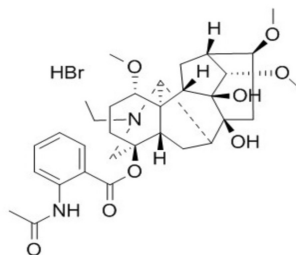

BIOLOGICAL ACTIVITY OR INHIBITORS

Fos protein expression in dorsal horn of spinal cord and pain reaction can be suppressed by intraperitoneal injection of lappaconitine in a dose-dependent manner in rats, lappaconitine hydrobromide may reinforce the activity of pain modulation system in brainstem and inhibit the inputs of peripheral pain message through enhancing [1] Lappaconitine hydrobromide can remove inflammation and swelling, lower temperature and relieve heat, it also can be used for local anesthesia. Lappaconitine hydrobromide injection and shenfu Injection have biphasic effect on inducing differentiation and apoptosis of HL-60, and this will supply the experimental [3]

The clathrate with hydrobromide of lappaconitine (I•HBr-IV) has a high activity on the two models of arrhythmia. [4]

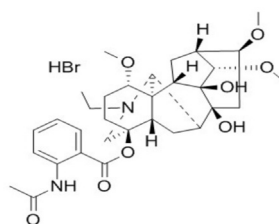
