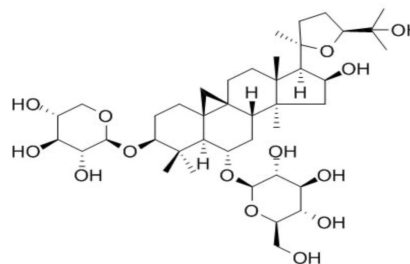

Astragaloside IV, a saponin isolated from *Astragalus membranaceus*, has been shown to protect the myocardium against ischemia/reperfusion injury, it also has beneficial effect in H/R-induced injury may be related to normalization of SR Ca²⁺ pump expression and, thus,

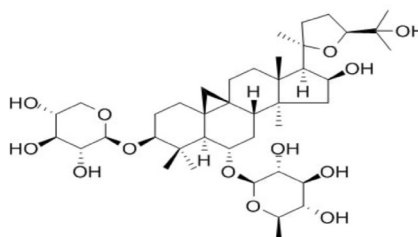
