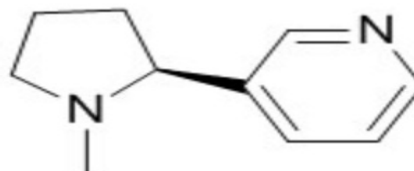

Nicotine is a potent inhibitor of cardiac A-type K⁺ channels, with blockade probably due to block of closed and open channels, this action may contribute to the ability of nicotine to

Nicotine is able to activate mitogenic signalling pathways, which promote cell growth or survival as well as increase chemoresistance of cancer cells, nicotine activates its downstream signalling to interfere with the ubiquitination process and prevent Bcl-2 from

denuding injury iliac artery, so it may contribute to the development of restenosis.

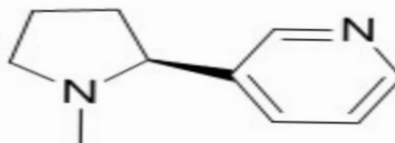
