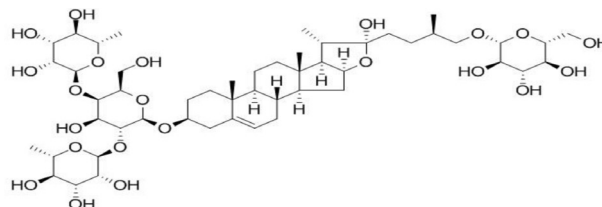

BIOLOGICAL ACTIVITY OR INHIBITORS

Protodioscin is cytotoxic against most cell lines from leukemia and solid tumors in the NCI's human cancer panel, especially selectively against one leukemia line (MOLT-4), one NSCLC line (A549/ATCC), two colon cancer lines (HCT-116 and SW-620), one CNS cancer line (SNB-75), one melanoma line (LOX IMVI), and one renal cancer line (786 - 0) with GI50 < or = 2.0 microM.[1]

Protodioscin appears to possess aphrodisiac activity probably due to its androgen increasing property.[2]

Protodioscin has antihyperlipidemic effect, its great availability in various vegetables and medicinal plants will be useful in developing health food supplement(s) and/or drug(s) against hyperlipidemia.[3]

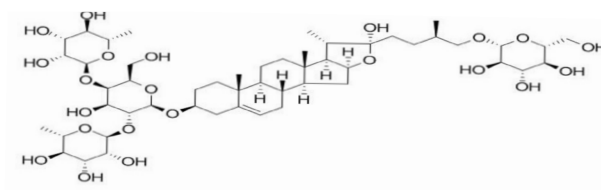
