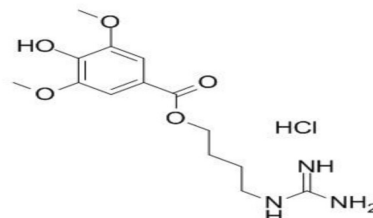

BIOLOGICAL ACTIVITY OR INHIBITORS

Leonurine hydrochloride (LH), a major alkaloid compound extracted from *Leonurus japonicus* Houtt. (Labiatae), is considered to have antitumor roles; LH increases the expression levels of caspase-3, caspase-9 and Bax/Bcl-2, it inhibits the proliferation and induces the apoptosis of H292 cells in a mitochondria-dependent pathway.[1]

Leonurine hydrochloride can inhibit osteoclastogenesis and prevent osteoporosis associated with estrogen deficiency by inhibiting the NF- κ B and PI3K/Akt signaling pathways, it might be a promising therapeutic compound to treat osteoclast-related diseases, such as osteoporosis.[2]

Leonurine hydrochloride can remarkably elevate the serum estradiol level in rats, but has no obvious effect on progesterone level; LH has an inhibitory effect on bleeding caused by incomplete abortion, the mechanism may be related to up-regulation of the E2 level, leading to an increase in uterine contractions and evacuation of intrauterine [3]

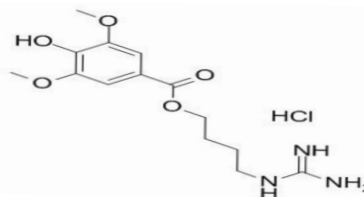
