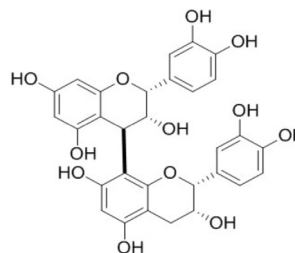

Procyanidin B2 (PB2) is a naturally occurring flavonoid widely found in cocoa, red wine and grape juice, PB2 could protect against oxidative stress- and chemical-induced injury in colonic cells by modulating the endogenous cellular defence, PB2 protects against oxidative injury in colonic cells and up-regulate the expression of GSTP1 via a mechanism

[1] that involves ERK and p38 MAPK activation and Nrf2 translocation.  
Procyanidin B2 is one of phenolic compounds in apple pomace, an agro-industrial byproduct in apple juice processing, PB2 at no less than 50 µg.mL(-1) could significantly suppress inflammation in the LPS-induced cells, shows that high pure PB2 prepared from

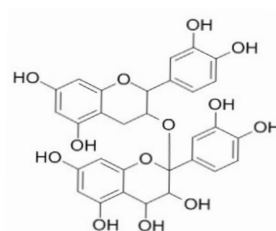
