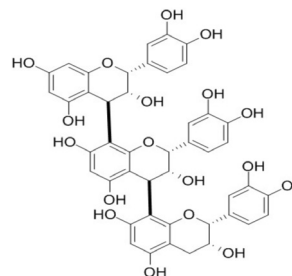

### BIOLOGICAL ACTIVITY OR INHIBITORS

In vitro, procyanidin C1 (PC1) can dose-dependently decrease Fc epsilon RI-mediated degranulation and cytokine production of mast cells, inhibit tyrosine phosphorylation of Syk and linker for activation of T cells, and the ROS generation in stimulated mast cells. PC1 suppresses Fc epsilon RI-mediated mast cell activation by inhibiting intracellular signaling pathways, these observations provide evidence for the

of cardiovascular diseases.

Procyanidin C1 is the main active compound in the CC extract responsible for EMT inhibition and that procyanidin C1 could be useful as a lead compound to develop

anti-allergenic effects of the procyanidin-enriched apple extract.

Procyanidin C1-induced vasorelaxation is associated with the activation of the calcium-dependent NO/cGMP pathway, involving potassium channel activation, thus, it may represent a novel and potentially therapeutically relevant compound for the treatment

inhibitors of cancer metastasis and other diseases related to EMT.

Procyanidin C1 has anti-inflammatory effects, can inhibit IKKb activity in vitro and reduce the LPS-induced production of ROS, thus, it exerts the anti-inflammatory effects by inhibiting ERK1/2 and IKKb activity.[4]

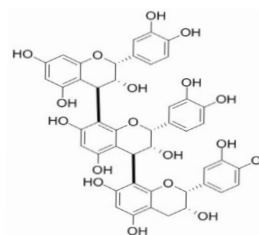
