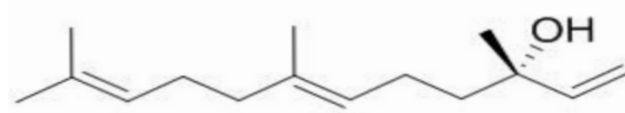

## BIOLOGICAL ACTIVITY OR INHIBITORS

---

Nerolidol, a sesquiterpene used as a food-flavoring agent and currently under testing as a skin penetration enhancer for the transdermal delivery of therapeutic drugs; nerolidol can inhibit the growth of *Leishmania amazonensis*, *L. braziliensis*, and *L. chagasi* promastigotes and *L. amazonensis* amastigotes with in vitro 50% inhibitory concentrations of 85, 74, 75, and 67  $\mu\text{M}$ , respectively; the in vitro activity of nerolidol against these parasites may prove a useful tool for the development of new drugs for the treatment of leishmaniasis. Nerolidol shows an inhibitory effect on carcinogenesis of the large bowel.[2]

Nerolidol displays antiulcer activity, as it significantly inhibits the formation of ulcers induced in different animal models. [3]

Nerolidol and eugenol have antifungal effect against *Microsporum gypseum* in a guinea pig model.[4]

Nerolidol has antifeeding activity for gypsy moth larvae from *Melaleuca leucadendron*. [5]

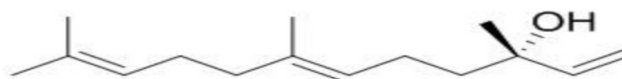
