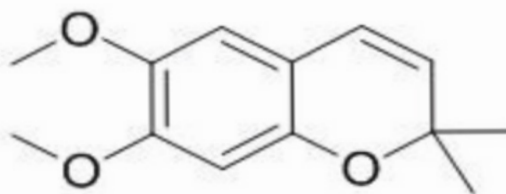

2. Precocene II is highly toxic to adult female *Rhodnius* and treatment of newly emerged females prevented oogenesis.
3. Precocene II, an insect growth regulator that is structurally related to several naturally occurring carcinogenic and non-carcinogenic alkenylbenzenes, is genotoxic and produces hepatic centrolobular necrosis in rats.

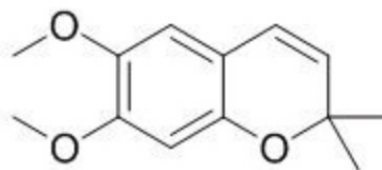
