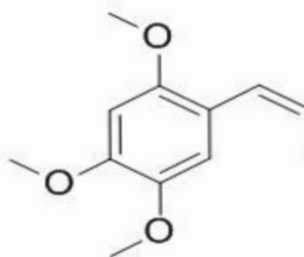

BIOLOGICAL ACTIVITY OR INHIBITORS

beta-Asarone has neuroprotection, it can afford a beneficial inhibition on both mRNA and protein expression of Bad, Bax, and cleavage of caspases 9 in rat hippocampus following intrahippocampal injections of Abeta (1-42), it may be a potential candidate for development as a therapeutic agent for Alzheimer's disease.[1]

beta-Asarone has anthelmintic activity using contractility of *Ascaridia galli*., it shows potent activity with IC50 values of 75.4 +/- 61.8 ng/mL.[2]

beta-Asarone has anticoagulant effect in the mouse and the rat. [3]

beta Asarone can cause liver and cardiac damages, it also has reproductive toxicity, beta asarone administered at a dose of 50mg/kg b.wt. is capable enough in bringing about moderate amount of degenerative changes in rat testis and altered antioxidant status.[4] beta-Asarone can inhibit colon cancer formation in vivo and in vitro by inducing senescence, since beta-asarone induces lamin B1 expression, a model is proposed in which beta-asarone inhibits colorectal cancer by inducing senescence through lamin B1.[5]

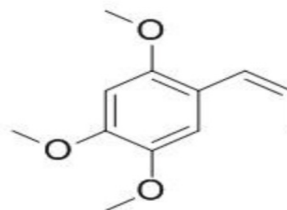
