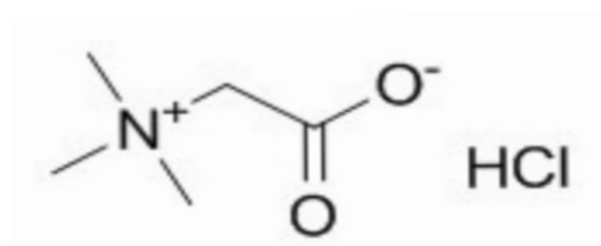

BIOLOGICAL ACTIVITY OR INHIBITORS

Betaine hydrochloride has protective effects against hypoxic mice.[1]
Betaine hydrochloride can increase the secreting of thyroxine (T3) and insulin and regulate the metabolism of organism by the hormones, thus it prompts fish growth and also improves intestine figuration.[2]
Betaine hydrochloride shows promise for treatment of nonalcoholic steatohepatitis. [3] Betaine hydrochloride has sedative, antipyretic and analgesic effects;when betaine hydrochloride was given orally 250~1000 mg/kg, the motor activity of mice was reduced 50~81%, the hypnotic effect of pentobarbital was markedly increased after oral administration of betaine hydrochloride at the dosage of 500 mg/kg or 1000 mg/kg; analgesic effect of betaine was demonstrated in mice by the hot plate method (55°C) and the acetic acid writhing test when given intraperitoneally at the dosage of 540 mg/kg or 900 mg/kg; betaine hydrochloride (500 mg/kg) given by gastric intubation was shown to have antipyretic effect in rabbits with iv TAB vaccine fever, but not in normotheric rabbits.[4]

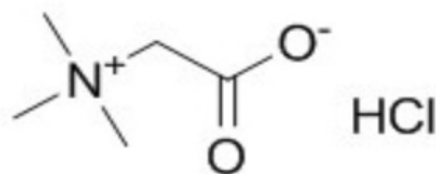
