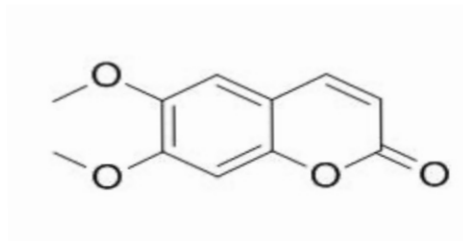

Scoparone is a phytoalexin with antifungal, anticoagulant, antianginal, hypolipidemic, vasorelaxant, immunosuppression, hepatoprotective, anti-allergic, antioxidant, and anti-inflammatory actions, it is used for the traditional treatment of neonatal jaundice. It inhibited the activities of PPAR γ , STAT3, NADPH-oxidase 1, and the expression of ERK, NF- κ B, JNK, PI3K. It augmented the expression of SOD1 and CAT.

BIOLOGICAL ACTIVITY OR INHIBITORS

Scoparone and emodin, the active principles isolated from *Artemisia scoparia* and *Polygonum multiflorum*, respectively, both exhibit immunosuppressive and vasorelaxant effects; emodin (10^{-6} – 3×10^{-5} M) and scoparone (10^{-6} – 3×10^{-5} M) can dose dependently relax rat thoracic aortic rings precontracted with phenylephrine, emodin (3×10^{-7} – 10^{-4} M) and scoparone (10^{-6} – 3×10^{-4} M) also can dose dependently suppress the responses of human mononuclear cells to phytohemagglutinin and mixed lymphocyte reaction; they may be useful as new templates for the development of better immunosuppressive agents with vasorelaxant actions for use against transplantation

[1] scoparone may serve as an effective therapeutic agent for allergic diseases. Scoparone has antianginal action, it can cause the increase in coronary flow and heart rate, but do not affect cardiac output, left ventricular pressure or left ventricular work in the rejection and autoimmune disease.

Scoparone can attenuate IgE-mediated allergic response in mast cells, it also can reduce the expression and secretion of pro-inflammatory cytokines, such as tumor necrosis factor- α and interleukin-6 in rat peritoneal mast cells (RPMC), suggests that

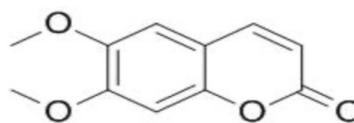
