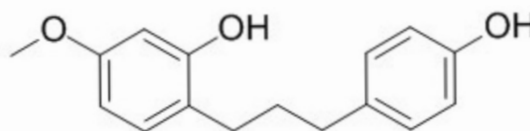

Broussonin A and nyasol suppress lipopolysaccharide (LPS)-stimulated inducible nitric oxide synthase (iNOS) expression at the transcriptional level through modulating NF- κ B and down-regulation of the Akt and ERK signaling pathways, these findings indicate that the suppressive effects of broussonin A and nyasol on iNOS expression may provide one

possible mechanism for their anti-inflammatory activities.

Broussonin A, tupichinol C, kazinol U, and (+)-(2R) kazinol I show estrogenic activity with ligand-binding activity of estrogen receptor, transcriptional activity of estrogen-responsive element-luciferase reporter genes, they also control the cellular gene expression levels of estrogen-responsive genes, phytoestrogens from *B. kazinoki* may have beneficial effects

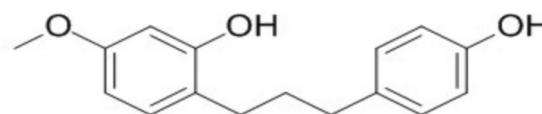
